# **Glass Gathering Meeting Minutes**

November 9, 2019 generously hosted by Harmony Stained Glass, Pasadena, Texas 18 members in attendance

#### **General Meeting**

Treasurer's Report: - Bank balance \$3049.57. One new member joined online from out of town.

<u>Bylaws Update Voting</u> – Discussion and voting at this meeting completed the process of making updates to our bylaws. The changes have been discussed in previous meetings, a summary of the proposed changes have been emailed to the membership twice, and online voting was provided for those who could not be present. Two online votes were cast. The vote passed revisions #1 and #2 unanimously, and revision #3 which unanimously with two abstentions.

### Approved revision #1:

Article VIII, 1A

Current: "General Membership Meetings will be held the second Saturday of every month at Harmony Stained Glass in Pasadena, Texas or at another location agreed upon by the membership."

Change: "General Membership Meetings will be held monthly at Harmony Stained Glass in Pasadena, Texas or at another location agreed upon by the Executive Board with a schedule being provided at the beginning of the calendar year."

Why: Gives greater flexibility to monthly meeting dates. Avoids conflicts with 2nd Saturdays in Houston Arts District, allows officers to adjust 3rd or 4th Saturdays to accommodate special events and holidays.

#### Approved revision #2:

Article X

Current: "The organization will maintain an official web site. The Executive Board will determine the content and guidelines of the web site." Change: "The organization will maintain an online presence . The Executive Board will determine the content and nature of the online presence." Why: Due to the constant evolution of electronic communication, this change allows for different platforms that are or will be available in the future.

### **Approved Revision #3:**

Article XIII

Current: "These bylaws may be amended at any general membership meeting by a two-thirds (2/3) vote, provided the amendment has been submitted in writing to all voting members at least one week prior to a general membership meeting at which voting on such proposal is to take place."

Change: "These bylaws may be amended at any general membership meeting by a two-thirds (2/3) vote, provided the amendment has been submitted by email to all voting members at least one month prior to a general membership meeting at which voting on such proposal is to take place. If members cannot be present to vote at that meeting, online voting will open two weeks prior to the meeting and close two days before the meeting to allow a tally of online votes to be complied for use at the meeting to check for duplicate votes and the two-thirds vote."

Why: This allows us to notify all paid members, not just those present at any given meeting and gives everyone a chance to participate in the discussion and to vote regardless of the member's ability to attend a particular meeting.

<u>2020 Calendar</u>: - suggestions were solicited from the floor for topics for our 2020 meetings. The executive committee will use the following suggestions when creating the schedule for next year:


- Mount-making with Frances Trahan
